Sidney, Baby Steps Resident Student-Mom:

Sidney moved into the Baby Steps home in the summer of 2019 with her 5-month-old baby girl, Ellie. This fall, Ellie turned 18 months old and passed the cut off age for living in the Baby Steps house. Because of the layout of the current property that we rent, we had the chance to offer an opportunity for Sidney to transition into more independence while still living at the Baby Steps property. She and Ellie moved into a 1-bedroom apartment where we continue to pay utilities, counseling, and ½ of the rent and daycare. It has been the sweetest gift to watch her confidently manage the responsibilities of school, work, and motherhood. We will miss her greatly when she graduates in May!

Caroline, Baby Steps Community Student-Mom:

Caroline came to Auburn University in 2018 as a freshman with her 3-month-old baby boy, Karter. She immediately got connected to the Baby Steps community. Imagine transitioning to college, being a new mom, and trying to find a community who could relate to your unique circumstance all while being a freshman. We were able to surround her with a community to remind her that she was not alone. This semester she will complete her undergraduate degree and head to medical school at VCOM-Auburn in the summer! We are so very proud of her and are eager to continue walking with her throughout the rest of her time at Auburn.
